


**ORDER: APPROVE PETITION FOR REDUCTION OF ASSESSMENT OF

Motion was made by Larry Gillespie, duly seconded by Brent Larson, to approve petition for reduction of assessment of real property roll 2020.


The vote on the motion was as follows:
