Motion was made by Chad McLarty, duly seconded by Larry Gillespie, to approve Claims Docket for numbers 1-192.

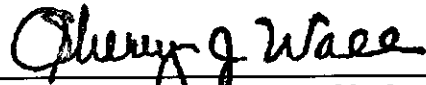
