


**ORDER: SPREAD ON THE MINUTES SALARY INCREASE FOR CIRCUIT

SUMMARY OF 2019 LEGISLATION

Senate Bill 2043

- Amends §25-7-13(2)(i)
- TOTAL Marriage License Fee - \$35
 - \$14 Domestic Violence
 - Any other deductions (\$1 Archives, \$1 County, and \$1 remaining \$21
 - Balance of the \$21 less other deductions to C
- Effective July 1, 2019

Senate Bill 2827

- Raises Salary Cap from \$90,000 to \$94,500
- Amends Registrar Salaries in §23-15-225 as follows:

- Amends §25-7-13(1)(m) to increase each day's court attendance for self and deputies from \$50 to \$75
- Effective January 1, 2020
