

ORDER: APPROVE CLAIMS DOCKET FOR CLAIM NUMBERS 386-590

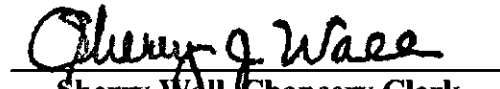
Motion was made by Chad McLarty, duly seconded by Larry Gillespie, to approve Claims Docket for numbers 386-590.
