

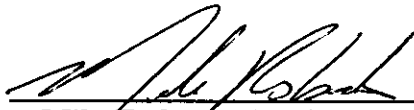
ORDER: APPROVE CLAIMS DOCKET FOR CLAIM NUMBERS 768-1102
