




Motion was made by Larry Gillespie, duly seconded by Brent Larson, to spread on the minutes the Tax Loss Certificate.

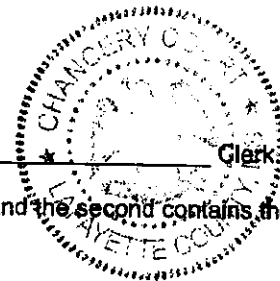

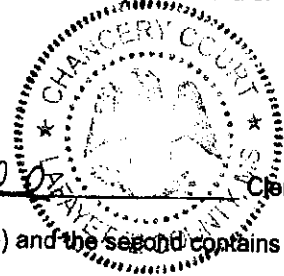
