MEMORANDUM OF UNDERSTANDING REGARDING EMS MEDICAL DIRECTOR SERVICES

This Memorandum of Understanding ("MOU") is entered by and between Joseph Holley, Jr., M.D. ("Dr. Holley"), City of Oxford ("City"), Lafayette County, Mississippi ("County"), and Shoals Ambulance, LLC d/b/a Baptist Ambulance ("Baptist Ambulance") (collectively referred to as the "Parties") as follows:

RECITALS

WHEREAS, Dr. Holley currently serves as the designated Medical Director for Baptist Ambulance's operations in North Mississippi, including in Oxford and Lafayette County.

WHEREAS, Baptist Ambulance provides emergency ambulance service in the City and County at the request of Baptist Memorial Health Care Corporation. In connection with those services, Baptist Ambulance personnel work in collaboration and cooperation with City Fire Department and County Fire Department emergency services personnel.

WHEREAS, City and County wish to designate Dr. Holley to be the Medical Director for the City Fire Department and County Fire Department emergency medical services, Dr. Holley is willing to serve in that capacity, and Baptist Ambulance has no objection to Dr. Holley serving in that capacity.

NOW, for good and valuable consideration, including but not limited to the covenants and agreements hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by the signatories below, the Parties agree through this Memorandum of Understanding to the following:

UNDERSTANDINGS

- City and County shall designate Dr. Holley as their Medical Director, and Dr. Holley shall serve
 in that capacity. To the greatest extent practicable, City, County and Baptist Ambulance shall
 operate under the same pre-hospital medical protocols approved by Dr. Holley.
- 2. The Parties agree to the above terms for a period of one (1) year beginning on the date the MOU bears the signatures of representatives of all Parties ("Initial Term"). At the end of the Initial Term, unless a party provides notice to the contrary, the MOU shall renew automatically for successive one (1) year terms. The Initial Term and any Renewal Term(s) collectively are the "Term."
- 3. Any party may terminate this MOU, with or without cause, upon thirty (30) days' written notice to the other parties.

This MOU may be executed in multiple counterparts and facsimile signatures shall be considered as valid as original signatures, and, when taken together, all counterparts shall constitute one and the same instrument.
