


**ORDER: AUTHORIZE PAYMENT TO CIRCUIT CLERK JEFF BUSBY FOR  
PROGRAMMING L&A TESTING AND REDISTRICTING**

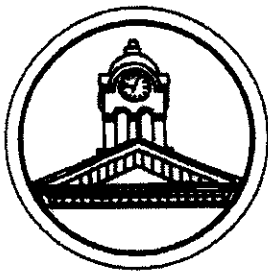

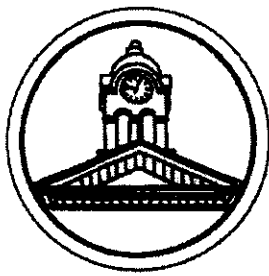
