


**ORDER: SPREAD ON THE MINUTES TAX LOSS CERTIFICATE FOR HOMESTEAD

Motion was made by Greg Bynum, duly seconded by Scott Allen, to spread on the minutes Tax Loss Certificate for Homestead reimbursement.


The vote on the motion was as follows:
