

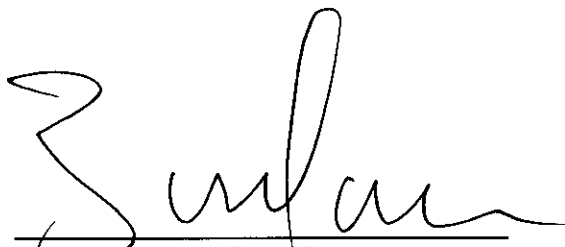
**ORDER: SPREAD ON THE MINUTES INSOLVENCY LIST FOR MOBILE HOMES,

Motion was made by John Morgan, duly seconded by Tim Allen, to spread on the minutes insolvency list for mobile homes personal property and returned checks list.

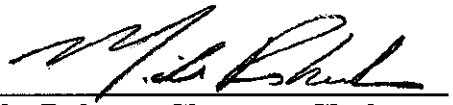
