

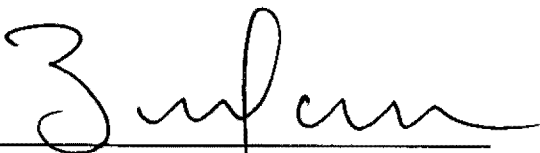
**ORDER: AUTHORIZE ADJUSTMENT OF SOLID WASTE ACCOUNTS FOR

Motion was made by Tim Gordon, duly seconded by Greg Bynum, to authorize adjustment of Solid Waste accounts for September, 2024.

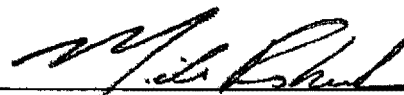
The vote on the motion was as follows:
