

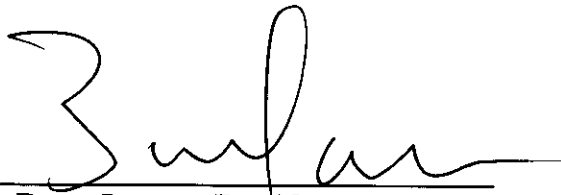
**ORDER: AUTHORIZE ADJUSTMENT OF SOLID WASTE ACCOUNTS FOR

Motion was made by Greg Bynum, duly seconded by Scott Allen, to authorize adjustment of Solid Waste accounts for October 2024.

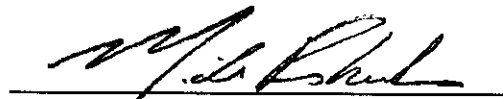
The vote on the motion was as follows:
