


**ORDER: SPREAD ON THE MINUTES APPOINTMENT OF COUNTY FIRE

Supervisor Greg Bynum, voted yes

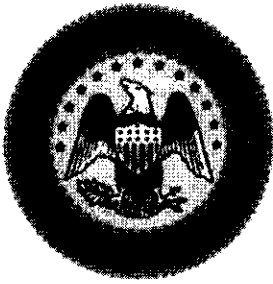
After the vote, President Larson, declared the motion carried, this the 16th day of December, 2024.
