


**ORDER: APPROVE RENEWAL OF RENTAL AGREEMENT WITH STENOGRAPH**

Motion was made by Scott Allen, duly seconded by Greg Bynum, to approve renewal of rental agreement with Stenograph.


The vote on the motion was as follows:
