


**ORDER: APPROVE ADJUSTMENT OF SOLID WASTE ACCOUNTS FOR
JANUARY 2025**


Motion was made by Greg Bynum, duly seconded by Scott Allen, to approve adjustment of solid waste accounts for January 2025.
