


**ORDER: APPROVE HOMESTEAD CHARGEBACKS FROM THE MISSISSIPPI

Motion was made by Greg Bynum, duly seconded by Scott Allen, to approve Homestead Chargebacks from the Mississippi Department of Revenue.


The vote on the motion was as follows:
