

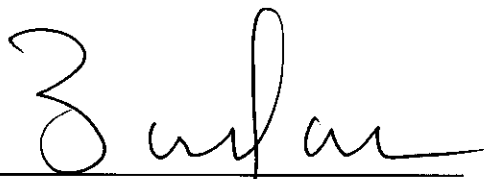
**ORDER: APPROVE THE NORTH MISSISSIPPI RURAL LEGAL SERVICES

After the vote, President Larson, declared the motion carried, this the 21st day of April, 2025.



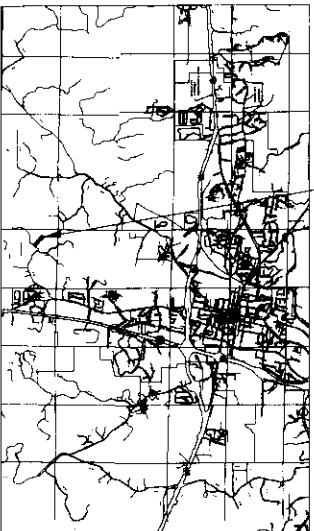
