


**ORDER: SPREAD ON THE MINUTES DEPARTMENT OF REVENUE CERTIFICATE
OF APPROVAL OF REAL AND PERSONAL ROLLS**


Motion was made by Scott Allen, duly seconded by Tim Gordon, to spread on the minutes Department of Revenue Certificate of approval for real and personal rolls.
