

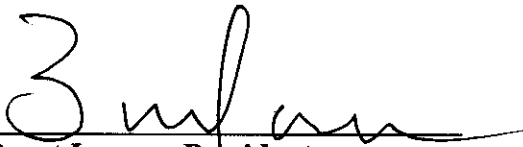
**ORDER: AUTHORIZE ADJUSTMENT OF SOLID WASTE ACCOUNTS FOR APRIL

Motion was made by Scott Allen, duly seconded by John Morgan, to authorize adjustment of Solid Waste accounts for April 2025.

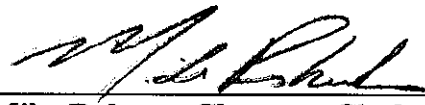
The vote on the motion was as follows:
