


**ORDER: SPREAD ON THE MINUTES ORDER APPOINTING AND SETTING
SALARY FOR THIRD CIRCUIT JUDICIAL DISTRICT STAFF ATTORNEYS BRETT
THOMAS AND BROOKE REEVES TO \$113,900.00 PLUS BENEFITS WHICH IS
FUNDED PRIMARILY FROM THE SUPPORT STAFF FUNDS, IF NOT AVAILABLE
SALARY MAY BE SUPPLEMENTED BY THE SEVEN (7) COUNTIES IN THE
DISTRICT IN WHICH LAFAYETTE COUNTY'S PERCENTAGE IS 25%**

Motion was made by Scott Allen, duly seconded by Tim Gordon, to spread on the minutes Order appointing and setting salary for Third Circuit Judicial District Staff Attorneys Brett Thomas and Brooke Reeves to \$113,900.00 plus benefits which is funded primarily from the support staff funds, if not available salary may be supplemented by the seven (7) counties in the district in which Lafayette County's percentage is 25%.


The vote on the motion was as follows:

ORDER APPOINTING AND SETTING SALARY FOR SUPPORT STAFF

IT IS ORDERED that Brett Thomas was appointed AOC Staff Attorney Level IV for Judge Grady F. Tollison, III, of the Third Circuit Judicial District, effective January 1, 2024. However, pursuant to the new Staff Attorney classification structure implemented by the AOC, Brett Thomas is now to be classified as an AOC Staff Attorney Level II.

Pursuant to Mississippi Code Annotated § 9-1-36, as amended, the annual salary of Brett Thomas is hereby increased from \$83,400 to \$113,900, plus benefits, which is to be funded primarily from the support staff funds of Judge Grady F. Tollison, III, of the Third Circuit Judicial District. Furthermore, this increase should apply, beginning on July 1, 2025.

If sufficient funds are not available from the support staff funds of the undersigned Judges of the District, said salary may be supplemented by the counties of the District in the percentages set forth below:

ORDER APPOINTING AND SETTING SALARY FOR SUPPORT STAFF

IT IS ORDERED that Brooke Reeves was appointed AOC Staff Attorney for Judge J. Kelly Luther and Judge Kent E. Smith of the Third Circuit Judicial District, effective February 1, 2024. Pursuant to the amended classification structure implemented by the Administrative Office of Courts, Brooke Reeves will be classified as an AOC Staff Attorney Level II, effective July 1, 2025.
