

**ORDER: APPROVE CONDITIONAL USE PERMIT FOR STONEWATER
ADOLESCENT RECOVERY CENTER'S SUMMIT PROGRAM**

Motion was made by John Morgan, duly seconded by Greg Bynum, to approve Conditional Use Permit for Stonewater Adolescent Recovery Centers Summit Program, limited to four (4) residential beds, subject to the following conditions:



1. Stonewater will immediately implement the electronic monitoring of all new residents participating in Stonewater's standard program and residents of the Summit Program (limited to individuals not transferring in from Stonewater's standard program) for a period not less than 15 days of initial admission, and a similar extended monitoring period for residents who exhibit noncompliant behaviors (placed in the slow-down phase). Electronic tagging devices shall be tamper resistant, be approved by the Sheriff's Department, provide notification to Stonewater security personnel when tampered with, and shall be able to be tracked for a multi-mile distance. Immediately upon a runaway leaving the Stonewater campus, the Sheriff's Department shall be provided with access to the electronic monitoring system for its use in locating the runaway resident. The electronic monitoring system shall be capable of generating monthly reports of runaways/elopements which will be provided to designated Sheriff Department personnel.
2. Upon prior notice, Lafayette County personnel, the Sheriff or his designees and designated Development Services personnel shall have 24 (twenty-four) hour access to Stonewater facilities to perform inspections pertaining to the provisions of the Settlement Agreement and/or conditional use permit.
3. Stonewater will provide a yearly report of its compliance with the provisions of the Settlement Agreement and the provisions of the conditional use permit, including providing access to designated County officials of the relevant Stonewater written policies and procedures.
4. All openings to the exterior of the building, windows and doors, shall have alarms and shall be activated during evening hours. Security personnel shall receive immediate notification of and respond to an open window or door.
5. The physical integrity of the perimeter fence shall be maintained at all times.
6. Designated Sheriff's Department personnel shall be included in the Community Response system and periodic mail communication to all local residents/addresses advising of the availability of Stonewater's Community Response system.
6. The Clinical Assistant job description will be modified to include the duties of detection and monitoring of elopements and maintaining visual and/or verbal contact with an eloping resident, (2) the creation and staffing of a "Recovery Advocate" position whose primary duty is to detect and monitor elopements 24/7 through constant monitoring of Stonewater's security camera system. In the event the Recovery Advocate is unable, temporarily or otherwise, monitor the camera system, other Stonewater staff will assume that responsibility.

7. The Settlement Agreement entered in the Lafayette County Chancery Court cause "Lafayette County, Mississippi v. Stonewater Addiction Recovery Center, LLC" (No. 2022-589-L) shall be amended to include the above conditions.
