


**ORDER: ACCEPT JAIL MEAL LOG AND AFFIDAVIT FROM JAIL

SECTION 19-25-74**





Before me personally appeared the undersigned, Johnny McDonald, who being known to me and first duly sworn, deposes and says as follows:






