

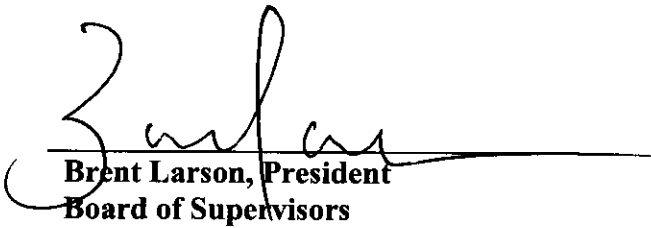
**ORDER: AUTHORIZE ADJUSTMENT OF SOLID WASTE ACCOUNTS FOR
JULY, 2025**

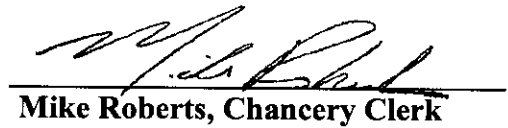
Motion was made by Scott Allen, duly seconded by John Morgan, to authorize adjustment of Solid Waste accounts for July, 2025.
