


**ORDER: SPREAD ON THE MINUTES SALARY CHANGES FOR

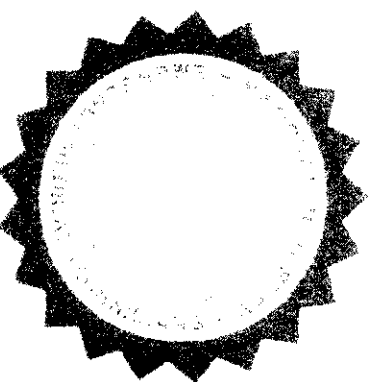
