


**ORDER: APPROVAL OF STUDENT INTERN KENNEDEE CLARK IN EMERGENCY

Motion was made by Scott Allen, duly seconded by Greg Bynum, to approval of student intern Kennedee Clark in Emergency Management for the Fall of 2025.


The vote on the motion was as follows:
