

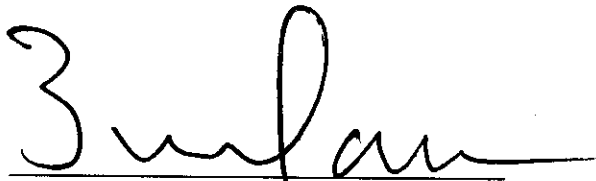
**ORDER: SPREAD ON THE MINUTES FULL-TIME EMPLOYMENT OF ROAD
