Records Search

Public Records Request: This office is paperless, which means all records are maintained on the web site (WWW.LINCOLNCIRCUITCOURT.COM) or here in the office on a TABLET. In the office there is no fee for viewing. The web site only charges for viewing the scanned document, indexing is free.

Reference the web site: Email request to dbairfield@co.lincoln.ms.us to have a case scanned to the web site if it's not currently. It usually takes one to two days to scan and publish on the web site after receiving the request. You then will be able to print it from your computer.
