


ORDER: APPROVE WRITE OFF OF SOLID WASTE ACCOUNTS FOR JULY

Motion was made by Mike Roberts, duly seconded by Chad McLarty, to approve write off of Solid Waste accounts for July.


The vote on the motion was as follows:
