

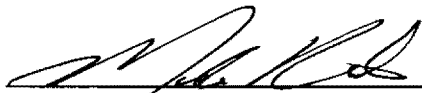
**ORDER: AUTHORIZE RECEIPT OF AND PAYMENT FOR REGIONS VISA

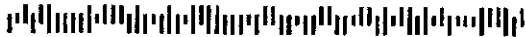
