Sorry did not get to you earlier today, we have been swamped. Would you please present for approval to the Board on Monday the following:

Initially we had asked for an increase from \$110.00 to \$150.00 for the Resolution Board for the November 3, 2020 Election only. As it stands right now we will have 6000 or more absentee ballots (normally would have between 1500 to 2000), which means that the Resolution Board will have a 12 hour or longer day. They are now processing at least 3 to 4 times more the number of ballots that would have been divided out between 18 precincts to process with less people. With this said we are asking that the previous decision on the increase to \$150.00 be changed to \$200.00 for the November 3, 2020 Election only. We have received a grant that we will be able to get reimbursed either all or a portion of the pay for the Resolution Board for this election.
