Motion was made by Brent Larson, duly seconded by Chad McLarty to approve write offs of Solid Waste Accounts for January 2022.

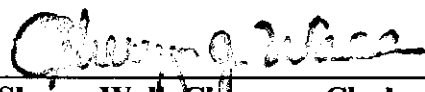
The vote on the motion was as follows:
