Motion was made by David Rikard, duly seconded by Brent Larson, to approve Solid Waste write offs for April 2022.

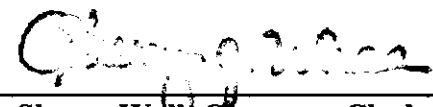
The vote on the motion was as follows:
