Motion was made by Larry Gillespie, duly seconded by Brent Larson, to approve write-off of Solid Waste accounts for May 2022.

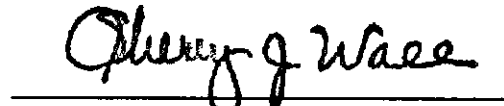
The vote on the motion was as follows:
