


**ORDER: APPROVE A 10% SALARY INCREASE ADJUSTMENT IN THE

Re: Promotions and Salary Increase

I have attached the Change in Position Form for my employees. As you all know, I have been out quite a bit this past year with my cancer treatments. All of my employees have taken on new responsibilities and done much more than a deputy clerk does. They have all taken the Passport Acceptance Agent course and successfully completed it. I'm promoting them to Senior Deputy Clerk and want to give each of them a 10% increase which I have listed below.

Additionally, from my Salaries Department of my budget, I've cut out the open position that Kerri Coleman had and one of the part-time open positions for back scanning records. This cut is a total savings of \$64,180.00 from my salaries department.

The increases for all employees total \$25,323.00 plus \$1937.21 for FICA and \$4,406.20 for PERS. This is a grand total of \$31,666.41 increase. That will leaving a savings of \$32,513.59 from the current year on salaries alone.
