First of all, I would like to thank you for the allowing the Lafayette County Fire Department to purchase cardiac monitors, automated CPR devices and video laryngoscopes. These products serve as excellent tools that enable us to provide high quality, cost effective, streamlined prehospital care to the citizens of Lafayette County. We have determined the Zoll X Series cardiac monitor, the Lucas Automated CPR Device and the AirTraq video laryngoscope are the products that are best suited for our department because of both interoperability and functionality.

The Zoll X Series cardiac monitor offers many functions in treating patients as well as interoperability and streamlining care while being cost effective. The monitor allows us to run 12 lead EKG's to assess for life threatening arrhythmias that require immediate intervention. It has Wi-Fi and Bluetooth capabilities that provide the means of streamlining care to the hospital and cath lab team for STEMI's. This decreases the first medical contact to intervention which has been shown to decrease morbidity and mortality. It also has the capabilities of monitoring carboxyhemoglobin levels which is useful in assessing for carbon monoxide poisoning in fire personnel during rehab. It also measures end tidal CO2 as well as tidal volume in intubated patients. Baptist Ambulance (Priority Ambulance) uses this same monitor which allows us to replace disposable equipment, as well as having full interoperable capabilities on scene. The Zoll X Series is compatible with ImageTrend software which we already use for documentation purposes. It is also compatible with the Zoll AED Plus which the department already uses.

The Lucas Device is an automated CPR device that allows us to provide high quality chest compressions during cardiac arrest. This allows responders to help with other duties and ensures compressions are compliant with American Heart Association recommendations. This device is smaller, lighter and cheaper when compared to the AutoPulse. The disposable part for the Lucas Device cost \$34.23 compared to the AutoPulse at \$122.50.

The AirTraq is a video laryngoscope that allows indirect visualization of anatomy during intubation. We are already utilizing this device within our department so no additional training is required. Baptist Ambulance is integrating the AirTraq into their practice currently which, again, will allow us to replace disposables that we have used when treating patients. In light of the COVID-19 pandemic, the AirTraq device reduces direct contact with respiratory droplets during intubation, which is safer for our clinicians. This device is also safer for patients as it increases first pass intubation success rates to 80.4% compared to 65.4% with direct visualization (no camera). The AirTraq can be programmed to record the intubation that can then be uploaded into ImageTrend software and attached to documentation.
