

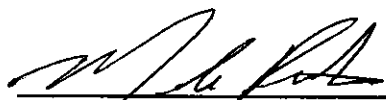
ORDER: AUTHORIZE SOLID WASTE ADJUSTMENTS FOR NOVEMBER 2022
