


**ORDER: ADOPT BOARD ORDER ACCEPTING CONTRACT FOR LOCAL SYSTEM


ORDER OF THE BOARD OF SUPERVISORS OF LAFAYETTE COUNTY ACCEPTING



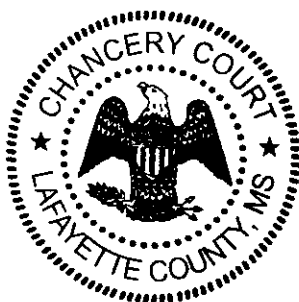
