

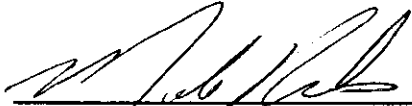
ORDER: SPREAD ON THE MINUTES THE MONTHLY CREDIT CARD REPORT
