

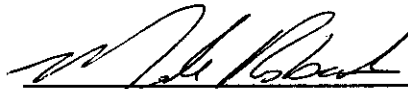
ORDER: APPROVE CLAIMS DOCKET FOR CLAIM NUMBERS 3189-3385

Motion was made by Chad McLarty, duly seconded by Brent Larson, to approve Claims Docket for numbers 3189-3385.

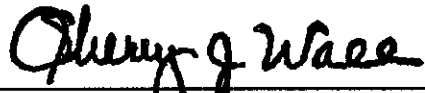
