



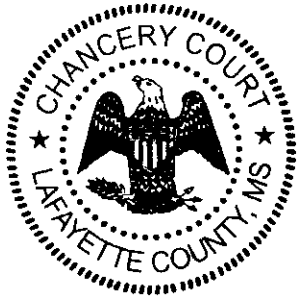

PROPERTY TAX ROLLS**




