Motion was made by Brent Larson, duly seconded by Larry Gillespie, to authorize amendment to Oak Ridge Condominium Plat.

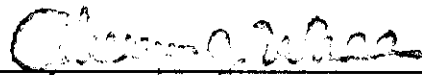

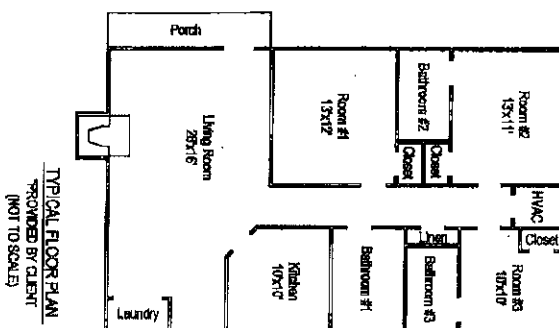
