

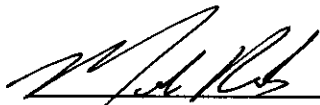
**ORDER: ACCEPT JAIL MEAL LOG AND AFFIDAVIT FROM JAIL

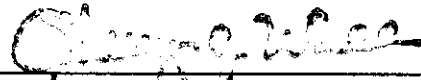
The vote on the motion was as follows:

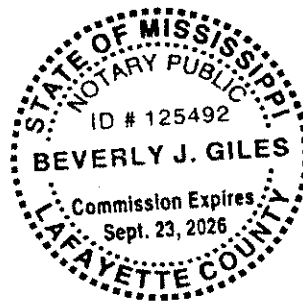

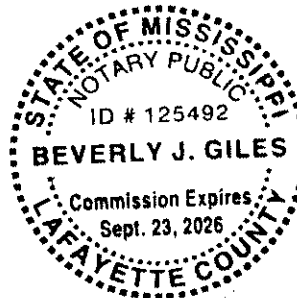
