

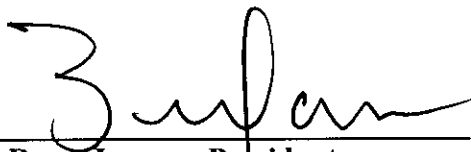
**ORDER: ACCEPT JAIL MEAL LOG AND AFFIDAVIT FROM JAIL

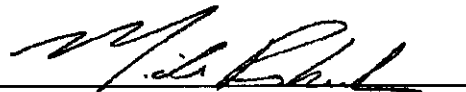
The vote on the motion was as follows:

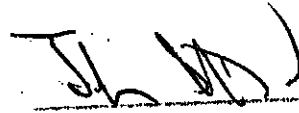

4. To the best of my knowledge, I find this invoice to be a true and correct match to the meal log in accordance with Mississippi Code Annotated § 19-23-74.

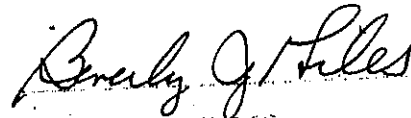

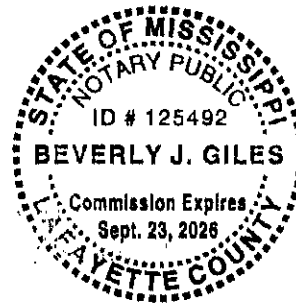

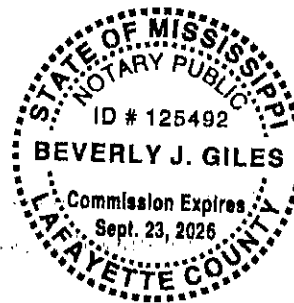
