AND PERSONAL PROPERTY**

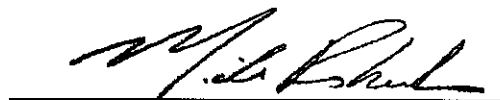
Motion was made by Tim Gordon, duly seconded by Brent Larson, to approve reductions and increases in assessment of Real and Personal Property.

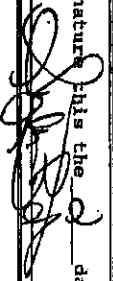
