Motion was made by Scott Allen, duly seconded by Greg Bynum, to authorize Claims Docket for numbers 1996-2173.

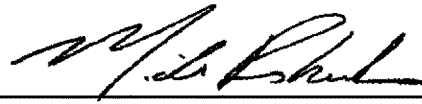
