


**ORDER: AUTHORIZE PART TIME EMPLOYMENT OF BRANDON S VANCE AS


The vote on the motion was as follows:

ORDER APPOINTING DRUG INTERVENTION COURT FIELD OFFICER

IT APPEARING UNTO THE COURT that an order was heretofore entered effective and signed the 30th day of October, 2007 establishing a Drug Intervention Court program for the 3rd Circuit Court District and which was lawfully established pursuant to 9-23-1, MCA, hereinafter referred to as the "Drug Intervention Court".

The Drug Intervention Court actually began operation on January 1, 2008, and incident thereto it is indispensable that a Drug Intervention Court Field Officer be appointed to complete the day-to-day operations of the Drug Intervention Court.

Accordingly, by this Order the Court formally appoints Brandon S. Vance as a Third Judicial District Drug Intervention Court Field Officer III and lab analysis technician.

Pursuant to 9-23-11, the Court sets forth herein the terms and conditions of said employment, as follows:

1. His wages shall be \$30.65 per hour as a part-time employee effective this date February 5, 2024. He shall remain in such employment until further order of the Court and at that hourly wage with approved raises in accordance with AOC guidelines.
2. He shall be deemed an employee of Lafayette County, Mississippi insofar as being covered under worker's compensation and the statutory immunity accruing to an employee of the Mississippi Tort Claims Act.

This Order shall be spread upon the official Minutes of this Court in each county in the Third Circuit Judicial District, Benton, Calhoun, Chickasaw, Lafayette, Marshall, Tippah and Union.
