


**ORDER: AUTHORIZE PAYMENT TO PERS FOR EMPLOYER SHARE OF CIRCUIT

Motion was made by John Morgan, duly seconded by Greg Bynum, to authorize payment to PERS for Employer Share of Circuit Clerk's Salary.


The vote on the motion was as follows:


