QUITCLAIM DEED

For and in consideration of the sum of ~~Twenty~~ ~~100~~ ~~Dollars~~ ~~100~~ Dollars, (\$10.00), cash to us in hand paid, and other good and valuable considerations, the receipt of all of which is hereby acknowledged, we, the undersigned, ROGERDALE WILSON and FERDINE SPEARS do hereby sell, convey, and quitclaim unto CHARLES LEE our undivided interest in and to the following described property situated in Pike County, Mississippi, to-wit:

The North Half of the Southeast Quarter of the Northeast Quarter (N $\frac{1}{2}$ of SE $\frac{1}{4}$ of NE $\frac{1}{4}$), Section 32, Township 2 North, Range 8 East, Pike County, Mississippi: beginning at the Northeast corner of the Northeast Quarter (NE cor.
