DECREE APPOINTING GUARDIAN

This cause came on this day upon the Petition of Mark Slaton and joining petitioners, for the appointment of a Guardian to have the charge and management of the person and estate of Phyllis H. Slaton, and upon evidence heard, and the Court after duly considering all of the same, does now find as follows:

That your petitioner, Mark Slaton is the son of Phyllis H. Slaton, and is an adult resident citizen of Pike County, Mississippi, whose address is Route 4, Box 40-C, Summit, Mississippi 39666 and is qualified to file this Petition pursuant to Section 93-13-281 of the Mississippi Code 1972, (Annotated); and

That Phyllis H. Slaton, the person for whom the Guardianship is sought to be established, has been served with process as provided by law; and

That Dock B. Slaton, Husband of Phyllis H. Slaton, (now deceased), Ruby Chirinos, daughter of Phyllis Slaton, Carol Marie Parker, daughter of Phyllis Slaton and Dock Maxie Slaton, son of Phyllis Slaton have joined in this petition with the petitioner evidencing their desire that Mark Slaton be appointed Guardian; and

That the parties are before the Court and that the Court has jurisdiction of the parties and the subject matter; and

That all parties have joined in this petition for the purpose of consenting thereto and requesting the relief stated.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that Mark Slaton is responsible, fit, and is hereby appointed as guardian of the person of Phyllis H. Slaton.

IT IS FURTHER, ORDERED, ADJUDGED AND DECREED that Letters of Guardianship shall issue to the person Mark Slaton upon his taking the oath as prescribed by statute and posting bond in the amount of \$ 5000.00.

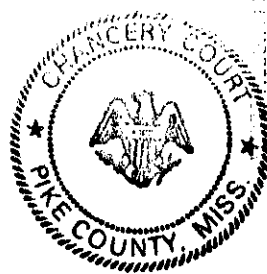


