That the Grantors herein constitute the sole and only heirs-at-law of Luther Smith, deceased, who died

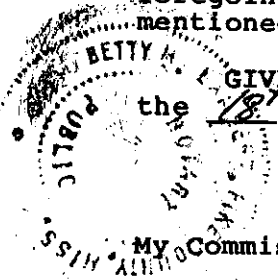
on the 19th day of May, 1973, survived by his wife, Harriett Smith, and his three children, Gene Smith, Addo Smith, and Napoleon Smith.

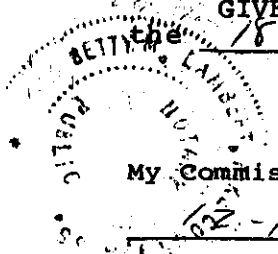
